The undersigned is informed and believes that:

COUNT 1

On or between January 1, 2010 and December 31, 2012, in the County of Santa Barbara, the crime of CONSPIRACY TO COMMIT A CRIME, in violation of **PENAL CODE SECTION 182(a)(1)**, a Felony, was committed by ISMAEL CANCINOS and MERCEDES ALVAREZ, who did unlawfully conspire together and with another person and persons whose identity is unknown to commit the crime of 1ST Degree Residential Burglary, in violation of Section 459, of the Penal Code, a Felony; Theft From an Elder, in violation of 368(d) of the Penal Code, a Felony; Grand Theft by False Pretense, in violation of section 487(a) of the Penal Code, a felony; Fraudulent Loan Modification, in violation of section 2945.4 of the Civil Code, a Felony, and Dissuading a Witness From Reporting a Crime, in violation of Section 136.1(b)(1) of the Penal Code, a felony, and that pursuant to and for the purpose of carrying out the objects and purposes of the aforesaid conspiracy, the said defendant(s) committed the following overt act and acts at and in the County of Santa Barbara:

- 1. Forged Loan Modification Documents;
- 2. Received Payment in Advance of Loan Modification;
- 3. Committed Perjury in Bankruptcy Court; and
- 4. Engaged in Business Practice Under Civil Code Section 2945.8 Without a Required Contract

SPEC ALLEG - AGGRAVATED WHITE COLLAR CRIME

It is further alleged, pursuant to **Penal Code section 186.11(a)(3)**, that the offenses set forth in COUNTS 1 THROUGH 86, are related felonies, a material element of which is fraud and embezzlement, which involve a pattern of related felony conduct and the pattern of related felony conduct involves the taking of more than one hundred thousand dollars (\$100,000).

SPEC ALLEG-EXCESSIVE LOSS-OVER \$100,000

It is further alleged AS TO COUNTS 1 THROUGH 86 that the above offense is a theft of over \$100,000, within the meaning of Penal Code section 1203.045(a).

COUNT 2

(LOCATION: 1127 W. GAYLENE DRIVE, SANTA MARIA, CA)

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section** 1192.7(c)(18).

It is further alleged that the above offense is a violent felony within the meaning of **Penal Code Section** 667.5(c)(21).

It is further alleged that the above offense is a violation of **Penal Code Section 462(a).**

SPEC ALLEG – SERIOUS/VIOLENT/REGISTERABLE SEX OFFENSE FELONY

It is further alleged that the above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and/or a violent felony described in subdivision(s) of Penal Code section 667.5 and/or an offense requiring registration under the provisions Penal Code sections 290 et seq, pursuant to Penal Code section 1170(h), that the defendant is ineligible for a state prison sentence to be served in the county jail.

COUNT 3

On or about May 16, 2011, in the County of Santa Barbara, the crime of THEFT FROM ELDER OR DEPENDENT ADULT, in violation of **PENAL CODE SECTION 368(d)**, a Felony, was committed by ISMAEL CANCINOS and MERCEDES ALVAREZ, who committed theft, embezzlement, forgery, fraud, or identity theft with respect to the property or personal identifying information of an elder or dependent adult, said property, goods, or services taken or obtained having a value exceeding \$950.00, TO WIT: \$2,500.00, and knew or reasonably should have known that said person, ANASTACIO HERNANDEZ DEL RIO (DOB: 11/01/1934), was an elder or dependent adult.

- 1) Did claim, demand, charge, collect, and receive compensation before said foreclosure consultant had fully performed each and every service the foreclosure consultant contracted to perform and represented she would perform, all in violation of Civil Code Section 2945.4(a);
- 2) Did induce or attempt to induce any owner to enter into a contract which does not comply in all respects with Sections 2945.2 and 2945.3, all in violation of Civil Code Section 2945.4(g).

COUNT 6

- 2) Did induce or attempt to induce any owner to enter into a contract which does not comply in all respects with Sections 2945.2 and 2945.3, all in violation of Civil Code Section 2945.4(g).

- 2) Did induce or attempt to induce any owner to enter into a contract which does not comply in all respects with Sections 2945.2 and 2945.3, all in violation of Civil Code Section 2945.4(g).

- 1) Did claim, demand, charge, collect, and receive compensation before said foreclosure consultant had fully performed each and every service the foreclosure consultant contracted to perform and represented she would perform, all in violation of Civil Code Section 2945.4(a);
- 2) Did induce or attempt to induce any owner to enter into a contract which does not comply in all respects with Sections 2945.2 and 2945.3, all in violation of Civil Code Section 2945.4(g).
